

Statement of Academic Honesty

Selective Enrollment Elementary School Admissions Test

The rules and procedures listed below are designed to ensure academic honesty. The goals of the testing session are for each student to have an equal opportunity to demonstrate their academic skills, that students who do their own work are not unfairly disadvantaged by students who do not, and that scores reported for each student are valid and reliable.

Students Will Be Disqualified from Testing and Their Parents Notified for any of the following:

- Continuing to write after time has been called on that test.
- Looking back at a test on which time has already been called.
- Looking ahead in the test booklet.
- Looking at another examinee's test booklet/answer sheet.
- · Giving or receiving assistance.
- Working on a different portion of the test than where they are supposed to be.
- Using any device to share or exchange information at any time during the tests or during breaks (all electronic devices, including cell phones, must be turned off from the time you are admitted to test until you are dismissed after testing concludes). Electronic devices cannot be used during bathroom breaks.
- Attempting to remove test materials, including test questions or answers, from the test room by any means.
- Writing in test booklets or using scratch materials on sections where it is not allowed.
- Creating a disturbance or allowing an alarm or phone to sound in the test room.

The rules and procedures listed below are designed to ensure academic honesty and to protect you and the content of the exam. The goals of the testing session are for each student to have an equal opportunity to demonstrate their academic skills, that students who do their own work are not unfairly disadvantaged by students who do not, and that scores reported for each student are valid and reliable. It is critical that the best online and paper-pencil exam experience is provided to you while protecting and promoting academic integrity. Depending on the severity of the violation there are varying levels of consequences including terminating a test session, invalidating test results, and disqualifying you from taking this exam.

Students Will Be Disqualified from Testing and Their Parents Notified for any of the following:

- · Talking during test administration.
- Usage of any device to share or exchange information at any time during the tests or during bathroom breaks (all electronic devices, including cell phones, must be turned off from the time you are admitted to test until you are dismissed after testing concludes).
- Taking photocopies, screenshots or camera shots of test materials
- Using calculators (exception: a 4-function calculator allowed for students with district/state testing accommodations via a public school 504 Plan or Individual Education Plan- Section 10C).
- Looking at or working on a section of the test in which time has already been called.
- Looking at or working ahead in sections not yet assigned by the proctor.
- Looking at another examinee's test materials.
- Giving or receiving test assistance.
- Attempting to remove test materials, including test questions or answers, from the test room by any means.
- Using dual screens/monitors.
- Creating a disturbance or allowing an alarm or phone to sound in the test room.

Please do the following:

Clear your workspace from items unrelated to testing. You should have the test taking device, pencils, and proctor-provided scratch paper. All scratch paper must be turned in to the proctor at the conclusion of the exam.
